The individuality of a tumour manifests itself principally in its histological appearance and the extent of spread at the time of diagnosis. The histological classification of a tumour depends on two main parameters, typing and grading, and a number of additional parameters which may apply to selected examples. Histological Typing This divides tumours of a given organ into different types according to their direction of differentiation. Although this may frequently indicate the underlying histogenesis of the tumour, it may be difficult or impossible to identify the cell of origin.
